TOURISM AND HOSPITALITY INDUSTRY MAY CREATE 50 MILLION JOBS IN 5-7 YEARS. **SAYS HAI**

Hotel Association of India (HAI) recently said that the hospitality and tourism sector expects to create 50 million direct and indirect jobs in the next 5-7 years but government support is reguired for getting the full infrastructure status at Centre and industry benefits in the states to tap the employment potential.

The infrastructure status for the hospitality sector can push up investments not only to create accommodation, but also in the process boost income and employment generation, said Puneet Chhatwal, immediate past president HAI and the Managing Director and CEO of Indian Hotels Company Limited, "While tourism is a pillar of development creating about 10 per cent of the total employment and contributing 8 per cent to GDP with a huge multiplier effect that can help inclusive growth, "there is often a gap between this realization and the actual policy implementation" while speaking to media persons

Addressing the press conference, K B Kachru, VP and now President HAI, said that in the last two years there has been "a rise of 271 per cent in hirings."

HOTEL ASSOCIATION OF INDIA SUCCESSFULLY CONCLUDES ITS 6TH HOTELIERS' CONCLAVE



The 6th HAI Hoteliers' Conclave was held on the 12th of February 2024 in New Delhi around the theme r Hospitality — The Engine for GDP Growth & Employment. In his inaugural address, Mr. Amitabh Kant, India's G20 Sherpa and former CEO of Niti Ayog, emphasized the Sector's role in generating employment and exhorted the Industry body and the hoteliers to highlight the potential of the Industry in creating jobs across skill sets, levels.

The hospitality business, like others, is experiencing a fresh boom that it has likely never seen before. And suppose it's only been a few years since they were caught off guard by the covid lockdown. From zero to hero, it has gained new excitement, confidence, and a strong view for future development.

An 'ask' that would provide a new boost to more hotel rooms, as the current gap between demand and supply is only likely to increase. These two steps alone will generate new momentum in hotel construction.

Smriti Irani, Union Minister proudly revealed that she was the daughter of a former Taj Mahal Associate. She had seen the contours of the hospitality sector as a benevolent and compassionate employer as a young kid who owes her education to a Taj fellowship. Delhi's Lieutenant Governor, Vinai Kumar Saxena, praised the current government's achievements in developing appropriate and much-needed infrastructure in the country.

IHCL WILL REMAIN INDIA'S NO. 1 HOTEL COMPANY, SAYS CEO

Indian Hotels Company Ltd (IHCL), which operates flagship hotels under the Taj brand as well as SeleQtions, Vivanta and Ginger Hotels, has opened six new hotels in the October-December quarter and two more in January, the company's managing director and CEO Puneet Chhatwal said. He added that with most new hotels being built on asset-light models, they will deliver high margins.

IHCL ENTERS INTO A STRATEGIC ALLIANCE WITH TREE OF LIFE RESORTS & HOTELS

Indian Hotels Company (IHCL) has announced a strategic alliance with the Tree of Life Resorts and Hotels, which was recently acquired by the Ambuja Neotia Group, offering IHCL's marketing and distribution network to its portfolio of 14 resorts across the country.



LEMON TREE HOTELS SIGNS A NEW PROPERTY IN MOTIHARI, BIHAR

Lemon Tree Hotels has signed a deal for an upcoming hotel in Motihari, Bihar. The proposed hotel will be managed by Carnation Hotels Private Limited, a subsidiary and the management arm of Lemon Tree Hotels. The hotel is expected to open by FY25 and will feature 50 well-appointed rooms and enticing amenities such as restaurants, meeting rooms, banquet halls, a swimming pool, a fitness center, a lounge, a bar, a spa, and other public areas.

RADISSON STRENGTHENS FOOTPRINT IN AYODHYA

Continuing its expansion plan in India, Radisson Hotel Group announces the signing of the 150-room Radisson Blu Hotel, Ayodhya. A greenfield project, the hotel is being developed by Jeewani Hospitality in partnership with EaseMyTrip and is expected to open in 2027. This is Radisson Hotel Group's second hotel in Ayodhya as it continues to invest in the potential of the city's immense historical and cultural significance. The group had in January 2024 announced the opening of Park Inn by Radisson Ayodhya.





IHCL AIMS TO STRENGTHEN ITS POSITION IN SPIRITUAL TOURISM, BY ADDING MORE HOTELS

Tata Group hospitality firm Indian Hotels Company Ltd is looking to strengthen its leadership position in spiritual tourism, developing properties in noted locations in India with spirituality expected to play a more significant role globally, according to a top company official.

The company currently has 66 hotels either operational or under development at spiritual destinations, including the latest hotspot Ayodhya, and will continue to grow the portfolio.

CHALET HOTELS WILL CONTINUE TO INVEST IN LARGE INVENTORY HOTELS

Chalet Hotels, a part of the K Raheja Corp group, has set ambitious plans to expand its portfolio of "big-box", or large inventory, hotels, aiming to add approximately 800 rooms to its offerings. Having earmarked ₹2,000 crore as current capital work-in-progress, the expansion will increase its total room count to 5,000 in the next three to four years.





APEEJAY SURRENDRA PARK HOTELS IPO BOOKED 3.7X IN THREE HOURS; RETAIL PORTION BOOKS OVER 9 TIMES

The initial public offering (IPO) of Apeejay Surrendra Park Hotels continued to receive a strong response from the investors during the second day of the bidding process, across all categories of investors. The issue, which kicked off Monday, February 5, was booked 2.4 times on day one. The Kolkata-based Apeejay Surrendra Park is selling its shares in the price band of Rs 147-155 apiece with a lot size of 96 shares and its multiples thereafter. The Rs 920-crore issue includes a fresh share sale of Rs 600 crore and offer-for-sale shares worth Rs 320 crore.
