#### **Dear Friends**

The industry continues to navigate a dynamic phase of growth and reinvention, driven by policy shifts and evolving traveler expectations. As per JLL's Hotel Momentum India (HMI) Q2 2025 report, the industry recorded a robust 10% sequential growth in RevPAR at the pan–India level compared to Q1 2025. This strong performance has continued to gain pace, carrying the momentum into the festive quarter. The average daily rates (ADR) held firm with a steady 5% year-on-year growth, reflecting the sector's resilience.

The recent reduction in GST from 12% to 5% is expected to further accelerate demand by making hotel stays more accessible for mid-dle-class and budget travelers—its positive impact likely to be visible from late September onward. This festive season, the extended Diwali weekend saw a significant uptick in hotel bookings across leisure destinations, including Pondicherry, Mahabalipuram, Udaipur, Jaipur, and Uttarakhand, with Goa leading the momentum.

Investor confidence remains robust and momentum is building across segments. The outlook for the coming months is bright. Anchored in collaboration, innovation, and optimism, the Sector stands ready to redefine India's travel landscape—one exceptional stay at a time.


